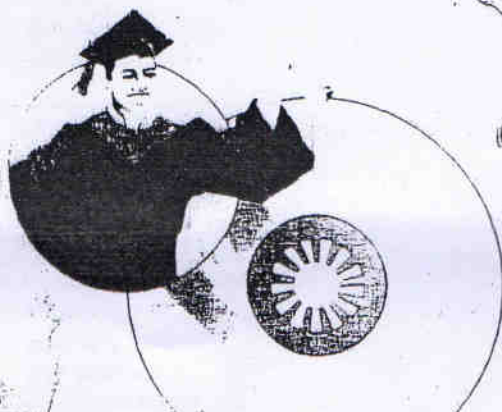
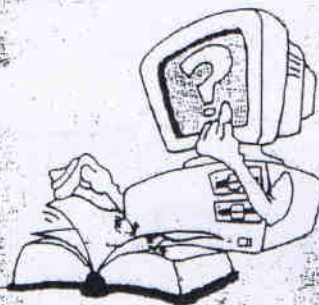

Principal UGC Act, 1956 as Section 12-B
W.E.F. 1st October, 1984 -Regarding.

I am directed to say that the University Grants
Commission (Amendment) Act, 1984 has come into force w.e.f.
1st October, 1984 vide notification No.F.12-7/84-Desk-U
dated 1st October, 1984 issued by the Ministry of Education,
Delhi, Government of India, published in the Gazette of
India, Extraordinary (Part II, Section 3 Sub-Section (ii),
Section 3 of the UGC, (Amendment) Act, 1984 provides that in the
Principal Act of 1956, Section 12-A is to be renumbered as
Section 12-B. The effect of the UGC, (Amendment) Act, 1984
will be that w.e.f. 1st October, 1984, Section 12-A of the
Principal UGC Act, 1956 would read as Section 12-B, which would
include the rules previously made under this Section.

This modification is brought to the notice of the
University for information and appropriate action.

It is requested that this may be brought to the notice
of all the colleges/institutions within the jurisdiction of
Banarus University.

The UGC Act, 1956 (as modified upto 1st October, 1984)
is being printed. A copy of the UGC Act, 1956 will be made
available to the University in due course.
