- **■** Types of taxes.
- Tax is not a charity but it is compulsory fees levied by the government.
- In 2017-18 financial year our Central government has collected 20 lakh crores as taxes directly and indirectly from the general public under current rates.

- **■** Explanation about Form 26[A]
- ► Filling of ITR Returns should be made in a prescribed format because if it is not made in prescribed format it is deemed that the returns are not filled. Therefore prescribed format is mandatory to file ITR Returns.
- Filling of Returns is made voluntarily irrespective of any notice from IT department or in any other form.
- Procedure for filling ITR
 - > Preparation of Income Statement of assesse.
 - > Selection of Form
 - > Filling of form with necessary information.
 - > Validation.
 - ➤ Uploading in income Tax Department website.
 - > Submission of form.
- Making of Digital Signature which is mandatory for certain assesses and optional for certain assesses.
